## Intended actions for 2024/25

What are your plans for 2024/25?	How are you going to action and achieve these plans?
Intent	Implementation
1) Introduce an extra playground PE session for each class per week.	Changed timetable and Forest School sessions to enable a 2 <sup>nd</sup> PE session for each class. Classes will now have 2 terms of Forest School per year. When it is not a classes term to have Forest School they will have an extra PE session on the school playground. This helps towards children achieving 60 active minutes!
2) Purchase new Football/Sports Kit	Research different kits and companies. Get quotes from more than one company. Involve children in design of new kit.
3) Provide 2 sessions of PE CPD for teaching staff in terms 4 and 6

1) Introduce an extra playground PE session for each class per week.	Class timetables will show that all classes have made sure that they carry-out the 2 <sup>nd</sup> weekly session of PE.
2) Purchase new Football/Sports Kit	Increased pride and desire to enter inter-school competitions and compete for the school.
3) Provide 2 sessions of PE CPD for teaching staff in terms 4 and 6	Development of Teaching skills in a variety of sports.
4) PE lead teach high quality PE sessions throughout EYFS, KS1 and KS2.	Children's sporting abilities, skill and fitness show clear progression of competence confidence and knowledge through carefully planned and well equipped PE lessons.
5) TA provide support for children with AEN enabling them to achieve to the best of their abilities during PE sessions.	Class and 1:1 TAs ensure that PE sessions are fully inclusive and focus on identifying and assisting children with specific needs in sport and gross motor issues as well as behavioral issues which may impact on their PE

1) Introduce an extra playground PE session for each class per week.	Class timetables clearly show that all classes have participated in a 2 <sup>nd</sup> weekly session of PE.
2) Purchase new Football/Sports Kit	Quote of £850 from Myclubgroup received and now in the process of choosing styles/colours.
3) PE lead teach high quality PE sessions throughout EYFS, KS1 and KS2.	PE lead has taught all classes PE sessions throughout this year, ensuring clear progression from year to year and class to class. Teaching all classes and age groups has ensured consistency and a clear line of development of skills technique and sporting knowledge.
4) TA provide support for children with AEN enabling them to achieve to the best of their abilities during PE sessions.	TA assistance has ensured that all children are able to access PE sessions at a level and in a method that best suits their needs. TA involvement has meant more sessions take place at the off-site, well equipped, sports hall.
